IN THE FRAMEWORK OF DEVELOPMENT COOPERATION BETWEEN THE CZECH REPUBLIC AND

BOSNIA AND HERCEGOVINA

#### PREAMBLE

The official development cooperation between the Czech Republic and Bosnia and Herzegovina is based on the principles of partnership, efficiency, transparency, and contributes to the promotion of mutual political and economic relations between the two countries.

In accordance with the government resolution no. 413 of 13 June 2012 approving Czech official development co-operation for the year 2013 including a medium term perspective till 2015, the Czech Development Agency, the Police of the Czech Republic and the State Investigation and Protection Agency of Bosnia and Herzegovina (hereinafter referred to as SIPA) wish to collaborate on the development co-operation project "Support of capacity building and technical assistance for the Diving Team of SIPA in Bosnia and Herzegovina" (hereinafter referred to as "project").

In this Memorandum of Understanding the Czech Development Agency, the Police of the Czech Republic and SIPA outline their intentions leading to successful implementation of the project.

The Czech Development Agency, the Police of the Czech Republic and SIPA agree to follow this Memorandum of Understanding with due care and efficiency and will provide all information concerning the project to each other. The Czech Development Agency, the Police of the Czech Republic and SIPA will discuss all matters that might arise within the context of this Memorandum of Understanding.

## ARTICLE I PROJECT SUMMARY

The project is part of the Czech development cooperation program which is ensured by the Ministry of Interior of the Czech Republic. Overall objective of this program is to contribute to the capacity building of security forces in Western Balkan Countries.

The specific objective of the project is to strengthen the capacity and efficiency of the Diving Team of SIPA. The main project outputs will be following:

- equipment for the Diving Team of SIPA (hereinafter referred to as "equipment") is delivered to the beneficiary institutions of the project mentioned above (ensured by the Czech Development Agency);
- SIPA diving experts are trained in the field of modern diving techniques and methods (ensured by the Police of the Czech Republic).

#### **ARTICLE II**

#### THE SCOPE OF THE PARTNERSHIP OF THE CZECH DEVELOPMENT AGENCY

The Czech Development Agency is prepared to:

- 1. Ensure selection procedure for providers of equipment, essential to the implementation of the project.
- 2. Ensure funding of equipment purchase in accordance with the resolution of the Government of the Czech Republic for respective years.
- 3. Ensure cooperation with the Police of the Czech Republic, SIPA and other involved institutions regarding the selection and purchase of equipment.

#### **ARTICLE III**

#### THE SCOPE OF THE PARTNERSHIP OF THE POLICE OF THE CZECH REPUBLIC

The Police of the Czech Republic is prepared to:

- 1. Nominate the responsible person to coordinate the activities regarding the implementation of the project.
- 2. Provide all necessary information relating to the implementation of the project.
- 3. Ensure training of the SIPA diving experts in the field of modern diving techniques and methods, including training of use of delivered equipment.
- 4. Elaborate technical part of the tender documentation for equipment purchase, including selection criteria.
- 5. Participate in assessment of tender bids for equipment purchase.
- 6. Provide for other measures within its competence which may facilitate the execution of the project.

# ARTICLE IV THE SCOPE OF THE PARTNERSHIP OF SIPA

SIPA is prepared to:

- 1. Nominate the responsible person to coordinate the activities regarding the implementation of the project.
- 2. Provide necessary information relating to the implementation of the project.
- 3. Ensure cooperation with the selected providers regarding the implementation of the project activities.
- 4. Ensure cooperation of state authorities on different levels, in particular regarding the customs and the value added tax.
- Ensure payment of value added tax for equipment deliveries to the Diving Team of SIPA or ensure that goods and services provided under the project will be exempted from VAT.
- 6. Provide for other measures within its competence which may facilitate the execution of the project.

#### ARTICLE V

All decisions relating to the project will be based on discussion and agreements between the Czech Development Agency, Police of the Czech Republic and SIPA. Any differences, which may arise in the application of the provisions of this Memorandum of Understanding, will be settled by means of negotiations or by any other manner mutually agreed upon.

## **OTHER ISSUES**

All notifications and documents provided or sent by the Czech Development Agency, Police of the Czech Republic and SIPA following this Memorandum of Understanding will always have a written form. All notifications and documents will be in English language.
