#### **Edification:**

Against Contracting authority's decision on the selection of the most suitable tender may be made filed objection, and within 10 days of receipt of this Decision pursuant to § 110 (4) of the Act. The contracting authority must not, in accordance with § 82 (1) of the Act before the expiry of the opposition period contract with the tenderer whose tender was selected as the most suitable according to § 81 of the Act. According to § 81 sect. 4 of the Act, the contracting person is entitled to make known the decision on the selection of the most suitable tender, by its publication on the contracting entity profile; in such case the decision on the selection of the most suitable tender shall be considered to be delivered at the point of time of publication on the contracting entity profile. In the above mentioned cases he decisions shall be considered to be delivered at the point of time of publication on the contracting will not be sent by mail.
